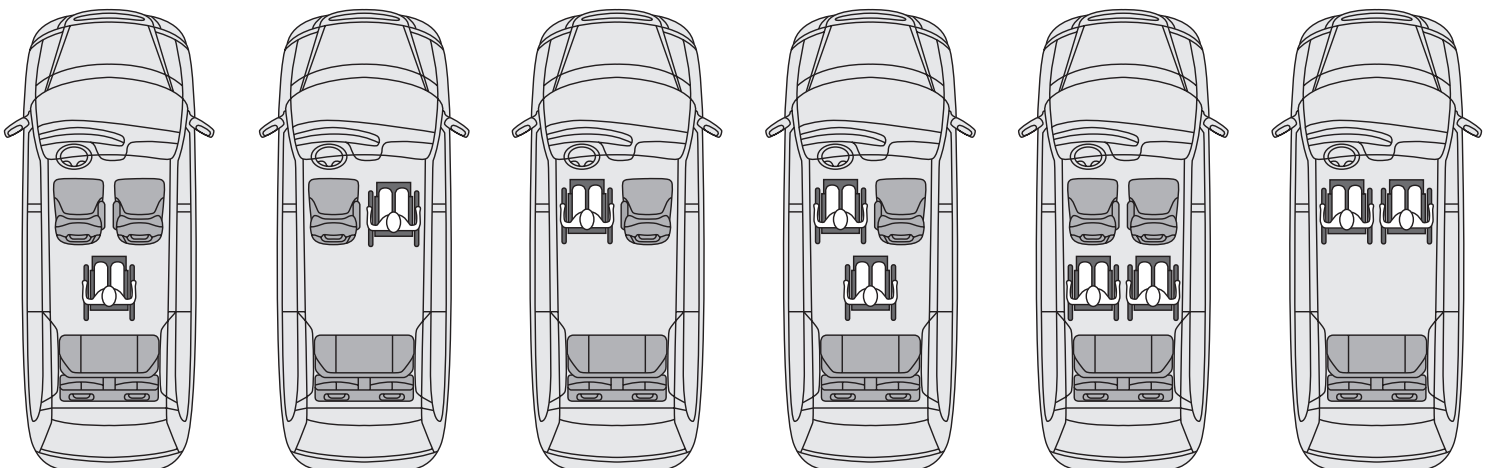
## Interchangeable Front Seats

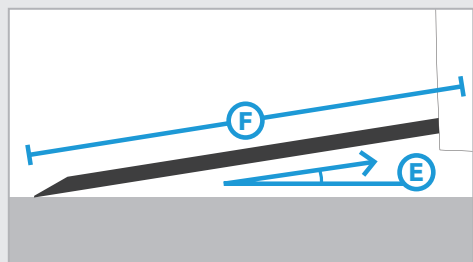
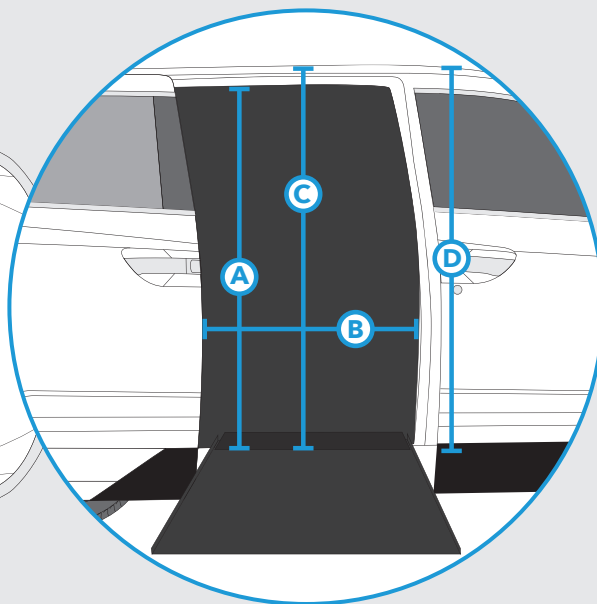
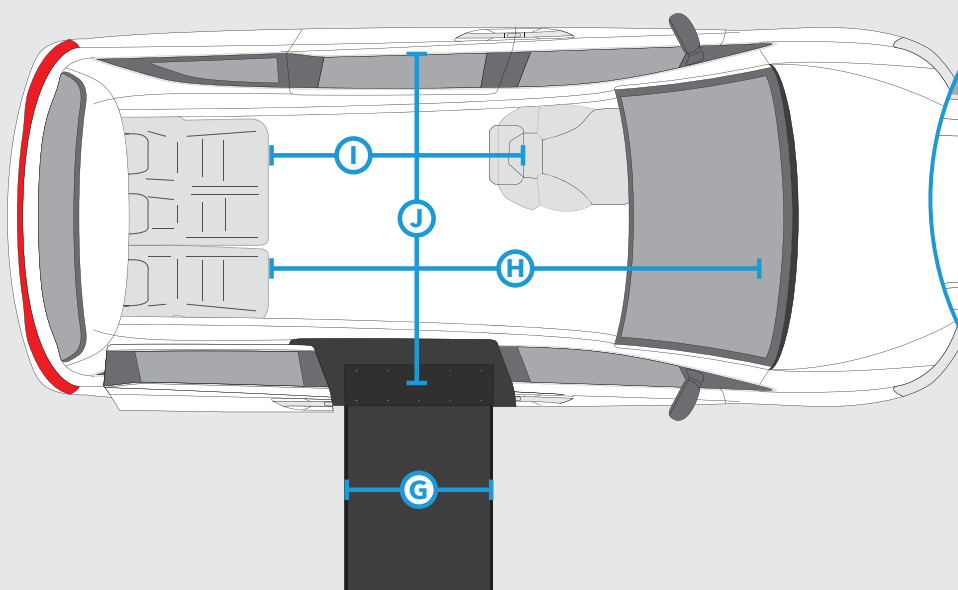
